LTMA NEWS

The LTMA is respectfully requesting that all sewer customers refrain from flushing articles such as rags, baby wipes or any non-biodegradable products down the toilet. This causes your pumping stations to become clogged with these articles. It becomes expensive to remove these articles from the pumping stations. We have seen an uptake in these articles being flushed, especially in the Oakwood Hills area. There is also a possibility of causing sewage backups into your homes when these rags or articles are flushed. So please, dispose of these articles properly, i.e., the garbage.

A reminder also that the LTMA will be flushing water lines the week of April 17 through April 21 from 8 AM until 3 PM. Some customers might experience low pressure and cloudy water for a short period of time. Please be patient while we complete this mandatory service.

Also a reminder that the LTMA board meetings have been changed to 7 PM to accommodate the public. These meetings take place the first Wednesday of each month. We invite everyone to attend.



We are pleased to continue to offer Recycling for Township Residents. We have been seeing quite a few of you taking advantage of this service and we appreciate your help with placing your items in the appropriate bins. As a reminder, we are only accepting paper, cardboard, and aluminum cans at this time. We have noticed that the cardboard bins get filled up most often and we now have a total of 5 blue bins designated for cardboard. There are 3 yellow bins for paper, and the large green receptacle is for the cans. Again, we appreciate everyone following the rules by keeping items sorted appropriately and not dropping off glass or plastics, as well as not leaving items on the ground when the bins are full. LIGONIER VALLEY TRAIL

The Ligonier Valley Trail has become very popular for walking and jogging along with some bicycle riders. We are delighted with the use it's getting and are working to add more trails, hoping to make it longer to give everyone some options concerning the amount of exercise they'd like to do or the direction they'd like to go.

Some home owners along the trail have informed us that the rules of the trail are not being adhered to and further, they are being negatively impacted by the misuse. The major issue is with people taking their dogs with them. While dogs are welcome on the trail, they must be on a leash and not allowed to run free. Some dogs are going into the yards homeowners who live along the trail and causing problems with their pets. Additionally, dog waste must be picked up. Some folks are picking up the waste but then throwing the poop bags out into the bushes or into the yards. There are dumpsters near the tennis courts where the waste bags can be deposited or you can dispose of them when you get home. We regret and condemn this behavior because it impacts everyone who uses the trail. We recently received a donated bench new waste receptacle to be installed near the bridge behind Weller Field. Please do not litter!

Additionally, the trail is closed from dusk until dawn. We've had several reports of people using the trail at night. Some people wear head lamps to see by while using the trail at night. It is worrisome to homeowners to see lights at night that shouldn't

be there. They are concerned about vandalism or fear of an attack of some kinds. According to one report, a car nearly hit a trail user at night when they met at Ligonier Camps Driveway. We ask users of the trail to be mindful of the rules and please abide by them.

Certainly most of the trail users are very thoughtful, respectful of others property and are delighted the trail exists for their enjoyment. We ask that everyone be aware that the trail runs through private property. All landowners have given permission allowing us to construct the trail on their property allowing everyone to use it. Please respect those owners and their property along the trail. Abiding by the rules will make for a better experience for everyone. We have worked hard to get the trail in place.....lets all pitch in and keep it nice for everyone.

Rules are posted on signs at both ends of the trail. The following is a review.

TRAIL RULES


- Please respect private property, <u>stay on trail</u>
- Trail open daily, dawn to dusk, no night use
- No motorized vehicles, except handicap scooters
- Keep pets on a leash, under control, pick up waste
- Littering prohibited. If you see litter, please pick it up
- · Ligonier Borough prohibits bikes on sidewalks

EMERGENCY SITUATIONS

Dear Ligonier Township Residents,

During the recent meetings that were held for the Comprehensive Plan, several residents questioned how they could be prepared for emergency situations that occur in our Valley.

The two most common emergencies that occur in Ligonier Township are flooding and trees down involving power/electrical lines due to storms and high winds.

Within the past month, emergency responders were called to rescue a car that was submerged in flood water covering a roadway. With all the information available in today's age telling people NOT to drive through standing water, this person chose to drive through a flooded roadway and became stranded and in need of an emergency rescue. Drivers are not able to tell how deep the water may be across a road and trying to cross can become a very dangerous situation in seconds. IF you come across a flooded road, in no circumstances should you try to drive through the water. Turn around and report the flooded area to 911 as soon as possible.

When a tornado struck Ligonier Valley a few years ago, one of the main concerns of emergency personnel was keeping people away from downed wires. If you see a wire that has fallen to the ground, NEVER assume it isn't electrified because it isn't sparking. Stay away from downed power lines and call 911 immediately. Live wires are extremely dangerous and can kill.


It is imperative to be prepared for an emergency situation that may arise with little to no warning. The Red Cross advises that you have the following necessities at hand in the event of an emergency:


- Water: one gallon per person, per day
- · Food: non-perishable, easy to prepare items
- · Flashlight and extra batteries
- First Aid Kit
- · Medications: 7 day supply
- Multipurpose tool
- Family and emergency contact information
- Blankets
- Extra Cash
