Ligonier Township Supervisors Regular Meeting Minutes

July 11, 2023

The Supervisors of Ligonier Township met in regular session at 7:00 p.m. Present were Chair, Dan Resenic; Vice Chair, Erik Ross; Secretary/Treasurer, Stephanie Verna; Supervisor, D. Scott Matson; and Supervisor, John Beaufort.

Also present were Manager, Michael Strelic; Solicitor, Dan Hudock; Engineer, Ben Faas; Chief of Police, Michael Matrunics; and Finance Officer, Bethany Caldwell.

Comments from the Public

There were no comments from the public.

Comments from the Supervisors

Supervisors Matson, Ross, and Verna had no comments.

Supervisor Beaufort reported the following:

Station 42 – 36 calls (Darlington)

Station 44 – 24 calls (Waterford)

Station 45 – 17 calls (Wilpen)

There were 77 total calls ranging from trees down, lines down, and one structural fire. The annual fundraising campaign letters were mailed out to residents, this is the fire departments primary fundraiser, and he'd like to remind people it's good to donate and it's also good to volunteer.

Supervisor Resenic – Reiterated Supervisor Beaufort's comments and said the Volunteer Fire Departments are crucial to the health of our community, so please consider giving generously.

 A motion was made by Erik Ross and seconded by Stephanie Verna to approve the minutes from the June 27, 2023 meeting. Motion carried.

There was an additional item not listed on the agenda as it was received yesterday – a letter from Westmoreland County requesting each municipality provide something to put in the time capsule for their 250th anniversary celebration. Supervisor Verna asked the Friends of Ligonier Beach to donate an iconic Ligonier Beach t-shirt, to which they agreed.

Manager Report

Mr. Strelic reported that Russell Standard will begin chip-sealing roads in town starting August 21. Mr. Strelic asked for drivers' patience while the crews work and advised drivers not to exceed 35 mph speeds to help the chips absorb into the tar and reduce damage to both the roads and vehicles. The staff are mowing along the roads in the northwest section of town and Mr. Strelic explained the tractor needs to finish this area before moving on to another. Supervisor Verna asked about the high priority roads and how they are maintained – they are mowed with hand held equipment, as opposed to moving the large mower across town.

Supervisor Ross said the roads scheduled for chip-sealing need a once over *before* they are chip-sealed – vegetation trimmed, ditches cleaned, etc. so that we don't drive heavy equipment on our freshly sealed roads. The township needs to be more proactive instead of reactive.

Engineer Report

Mr. Faas continues to monitor Dollar General's stormwater – they have modified the landscape plan and outlets.

Solicitor Report

Mr. Hudock reported that DEP has pushed back the Act 537 denial appeal deadline. LTMA staff met with outside accountants to prepare a proposal for MAWC and hope to go over it at next LTMA meeting. He is also working on a Hotel Road property code enforcement issue and will be filing with court of common pleas. He anticipates having something to sign off on at next meeting.

Supervisor Resenic requested an update on the Cherokee Lane complaint.

Police Report

Chief Matrunics went over his monthly report and said there has been an increase in scams. He reminded the public not to give money to people you don't know and don't provide any personal information over the phone.

Supervisor Verna asked that the General Fund Reserves CD schedule be provided at the next meeting.

- A motion was made by Stephanie Verna and seconded by John Beaufort to approve the General Fund bills as presented. Motion carried.
- A motion was made by Stephanie Verna and seconded by John Beaufort to approve the Liquid Fuels Fund bill. Motion carried.

Unfinished Business

 A motion was made by Dan Resenic and seconded by Scott Matson to appoint Tim Baacke to the Zoning Hearing Board to a term expiring 12/31/2025. Motion carried, 4:1, with Supervisor Verna voting nay.

There was a discussion about how to appoint the Ligonier Beach Study Committee members. Supervisor Verna stated that many people should participate in this process, the committee's role is to engage other people, need to appoint people that will function well in this role. It was decided that Supervisor Ross, Mr. Strelic and Ms. Eller will meet to prepare recommendations for committee membership. They will also discuss a potential kick-off event at the Ligonier Beach property to share information about this process with the public.

PennDOT Winter Maintenance Agreement – Mr. Strelic got clarification from PennDOT on how to modify the agreement. Mr. Strelic recommended as a business decision to continue maintaining Owl Hollow Road, but strike the Marietta and Springer Roads.

Supervisor Resenic asked if we plow those roads, will it damage our equipment. It will wear our cutting edges down faster.

Supervisor Beaufort asked about the fire trucks and school buses on these roads.

Chief Matrunics clarified it will add time to emergency services responses as these are low priority roads for PennDOT.

Supervisor Resenic asked if the township is being reimbursed enough to cover the cost. Mr. Strelic did not think we are breaking even, but did note there is a clause in the agreement the state will cover additional expenses associated with severe winters.

Supervisor Verna asked why keep maintaining Owl Hollow Road. We have to travel that road regardless, to get to other roads on the Township plow route. Supervisor Matson added that Owl Hollow had recently been worked on by PennDOT.

Supervisor Beaufort suggested that the Township continue to maintain the roads as it's in the public's best interest. Supervisor Resenic agreed PennDOT has us in a tough spot and the practice should continue if it's not going to cause an undue hardship.

 A motion was made by Stephanie Verna and seconded by John Beaufort to approve the PennDOT's five year winter maintenance agreement. Motion carried, 4:1. (Supervisor Matson voted nay.)

Westmoreland County stormwater grant agreement should be mailed out soon. This grant is 50/50 match, might use ARPA funds to cover the Township's match.

New Business

- A motion was made by Erik Ross and seconded by Scott Matson to approve Resolution 2023-R-14 regarding the Township's Pension Overpayments. Motion carried.
- A motion was made by Erik Ross and seconded by Stephanie Verna approving the advertisement of the Township's Audit request for proposals. Motion carried.

Executive Session

There was no executive session.

Mr. Hudock said he received an email from The Pittsburgh Retreat's attorney indicating they terminated their pending purchase agreement for the property off Austraw Road.

There were no comments from the Supervisors.


 A motion was made by Erik Ross and seconded by Stephanie Verna to adjourn the meeting at 7:35 p.m. Motion carried.
