• A motion was made by Dan Weimer and seconded by Paul Knupp to send the Oil & Gas zoning ordinance revisions to the County and set the public hearing date for October 13, 2020 at 7 PM. Motion carried.

- 2020 / 2021 Budget Review Report Mr. Carcella went over the budget report and noted that Real Estate transfer tax is up for September due to a \$3M property selling. Note items at the end of the report – suggestions to address the deficit.
- Public Works Committee Probationary Review of Cord Kelly (vote) Personnel committee recommends extending a full time permanent offer to Cord Kelly.
- A motion was made by Stephanie Verna and seconded by Paul Knupp to extend a full time permanent position to Cord Kelly. Motion carried.
- A motion was made by Paul Knupp and seconded by Dan Weimer to adjourn the meeting at 7:33 PM. Motion carried.
