Ligonier Township Supervisors Regular Meeting Minutes

January 4, 2021

The Supervisors of Ligonier Township met in regular session at 4:30 PM. Present were Chair, John Beaufort; Vice Chair, Paul Knupp; Secretary/Treasurer, Stephanie Verna; Supervisor, D. Scott Matson; and Supervisor, Dan Resenic.

 A motion was made by Paul Knupp and seconded by Stephanie Verna to approve the minutes from the December 8, 2020 meeting. Motion carried.

Manager Report

Recycling Program – the littering and cross contamination continues and staff cannot find any other providers at a comparable cost (~\$60/month). It is a popular program, but it is problematic. Suggest adding more containers or eliminate the program. The Supervisors directed staff to order more containers.

Solicitor Report

Mr. Korns drafted a records retention policy that follows the Pennsylvania record retention act, keeping sensitive records per the guidelines. Supervisor Verna asked about a policy with procedures, that would set a schedule, provide a list of records to be destroyed for their approval. Supervisor Verna requested R-21-03 be tabled so that procedures can be added to the policy.

Public Works Report

12/16/20 Snow Storm – Mr. Morgan went over the timeline of events that included pretreating the roads as well as the entire crew operating plows. There was a discussion about keeping up with the snowfall while balancing with staff safety. There were times staff were instructed to stand down when there were white-out conditions and low visibility.

Supervisor Matson asked about possible options, calling in the part-timers, using the high-lift and the graders.

Supervisor Resenic asked about the language in the union contract, does it say anything about the start times? (No)

There was a discussion about the current fleet, do we need to buy a bigger truck when these events happen once every few years.

There is a set schedule for clearing roads, the crew is assigned to roads. Supervisor Beaufort said the fire departments should be a high priority in the storms.

Supervisor Knupp thanked Mr. Morgan for staying the night during the storm. Not many people would do that.

Engineers Report

Mr. Faas went over the revised Act 537 Plan; the next step in the process is to publicly advertise its pending adoption and have a 30 day public comment period, then incorporate comments into the plan prior to submitting it to the DEP. This will be on the January 26 meeting agenda,

 A motion was made by Scott Matson and seconded by Dan Resenic to advertise the Act 537 Plan. Motion carried.

Ligonier Valley Police Department Report

In December there were 504 calls, 330 were from the 911 dispatcher, 11 criminal arrests, issued 45 vehicle citations – working on the 2020 annual report.

Zoning & Code Report

December was slow month for permits, but there was a lot of real estate transactions so lien letters were up and there were some big projects this year. No new code complaints.

Old Business

1. Ligonier Beach Request for Public-Private Partnership Proposals – no proposals received to date, however did receive an inquiry today regarding a music venue. Next Ligonier Beach Park committee meeting scheduled for February 4. Supervisor Beaufort has paperwork from the Department of Health to review, including the original permits.

New Business

- Resolution 21-02, 2021 Fee Schedule
 Supervisor Beaufort asked if any stormwater related fees have been collected. Mr.
 Nieusma said reviews started in the fall of 2020 with most of them being a \$25 no
 harm fee.
- A motion was made by Stephanie Verna and seconded by Paul Knupp to adopt R-21-02. Motion carried.
- 2. Resolution 21-03, Record Retention Policy tabled
- 3. Resolution 21-04, Fund Balance Policy

The General Fund balance on January 1, 2021 = \$222,639. This policy follows GASB Standards, sets targets and specifies how much funding should be carried over each year so that the Township does not need to borrow so it can get through the first quarter before real estate revenue is received in the spring.

- A motion was made by Stephanie Verna and seconded by Paul Knupp to adopt R-21-04. Motion carried.
- 4. LED Outdoor Lighting Quotes
- A motion was made by Paul Knupp and seconded Dan Resenic by to accept the low bid of \$8,100 with ½ funds from the general fund and ½ from the capital fund.

Supervisor Comments

Supervisor Knupp – thanked admin staff for managing the budget, thanked public works for their response during the snow storm, thanked the police for protecting the community.

Supervisor Matson – would like to see lights and cameras installed at the Township's other properties including the ash pile, the Beach Park, and fix the system at the complex, while giving the Supervisors and Police access.

Supervisor Verna – asked about the camera security process, requested a workshop be held after Mr. Korns sets up policy, also suggested presentations from service providers.

Supervisor Resenic – asked if the Township has looked at PV installation on the Township's building roof. Mr. Carcella explained that we did, but the roof needs improvement/repair and we'd like to combine this project with a possible PV field near an LTMA sewage plant to offset its electricity use.

 A motion was made by Stephanie Verna and seconded by Dan Resenic to adjourn the meeting at 5:41 PM. Motion carried.

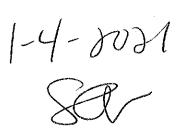
