

Ligonier Township Supervisors
Regular Meeting Minutes
February 9, 2021

The Supervisors of Ligonier Township met in regular session at 7:00 PM. Present were Chair, John Beaufort; Vice Chair, Paul Knupp; Secretary/Treasurer, Stephanie Verna; Supervisor, D. Scott Matson; and Supervisor, Dan Resenic.

Public Comment “A”

1. Leonard Butch – spoke on behalf of the private citizens group that has been working to save the Ligonier Beach swimming pool. He urged the Board to consider pool restoration as Ligonier Beach Park has the potential to be a regional destination in four seasons.

2. Tommie Korneke – commented that she values having a local police department in our rural community. She has had to use their service and they responded professionally and quickly.

- A motion was made by Stephanie Verna and seconded by Scott Matson to approve the minutes from the January 26, 2021 meeting. Motion carried.

Manager’s Report

Mr. Carcella reflected upon his goals when he was first hired and the changes the Township has undergone.

Engineer’s Report

Mr. Faas reported that the Act 537 Plan will be submitted this week. The road specs were provided for the projects the Township plans to bid out this spring.

Ligonier Valley Police Report

Chief Berger reported activity is down slightly due to time of year and training continues for the new hired officers.

Solicitor Report

Mr. Korn reported the Planning Commission held a workshop last week for the Township’s Code Enforcement Ordinance.

Zoning & Code Report

Mr. Nieuwma reported that activity is slow, but normal for this time of year.

- A motion was made by Paul Knupp and seconded by Stephanie Verna to approve Griffith’s Estate subdivision. Motion carried.
- A motion was made by Scott Matson and seconded by Dan Resenic to approve Whose Woods Plan subdivision. Motion carried.

- A motion was made by Scott Matson and seconded by Dan Resenic to approve Vanken Management Plan. Motion carried.

Correspondence:

1. 2019 Liquid Fuels Audit Report revision – the report was revised due to an administrative error discovered after reviewing the Clifford Woods Bridge project completion report (MS-999) to the Actual Use of State Funds annual report (MS-965). The MS-999 report covered 3 years (2017-19) and was completed in April 2019. The MS-965 for the 2019 year was completed in January 2020 and included an invoice that was inadvertently omitted from the MS-999. The Auditor concluded liquid fuels funds were “over spent,” however staff contends funds were “under reported,” as the invoice in question was/is an eligible expense under the Liquid Fuels grant program.

New Business:

1. Ligonier Beach Committee Report

Supervisor Beaufort thanked the committee for all their work.

Supervisor Verna suggested the Recreation Board move forward with a master site plan to incorporate some of the elements, giving people access and use of the property sooner rather than later.

- A motion was made by Stephanie Verna and seconded by Dan Resenic to advance the master site plan with an accommodation to possibly retain the pool. Motion carried.
2. Presentation by Alan Kugler, PA Futures & Michael Foreman, DCED
Mr. Kugler gave an overview of the DCED's "Strategic Management Municipal Process" (SMPP). This is an educational program that makes recommendations (that don't have to be implemented). A governmental study of intergovernmental cooperation experience is required by ballot. If approved, a government study commission is formed (by election) and reviews the structure and operations of current form of government and makes recommendations. If change is desired, then a consultant is hired to assist.

The Supervisors requested a workshop be scheduled to learn more about the SMMP program.

3. Employee Review – Russ Morgan

Personnel Committee met to discuss Russ Morgan's annual review, as previously stated salaried employees have been frozen at their 2020 rate.

- A motion was made by Stephanie Verna and seconded by Paul Knupp to give Mr. Morgan two personal days in addition to what is specified in the employee manual. Motion carried.

Public Comment "B"

Mr. Mike Getto, (739 2 Mile Road) provided a presentation regarding his neighbor's property and his health & safety concerns. Staff to follow up with Mr. Getto to provide him more information and ways to get involved.

Supervisor Comments

The Supervisors thanked tonight's presenters for their time.

- A motion was made by Stephanie Verna and seconded by Dan Resenic to adjourn the meeting at 8:42 PM. Motion carried.


