PUBLIC WORKS


Snow plow drivers, by definition, work in the worst winter conditions with the most limited visibility. Please give them space, distance, and most of all, patience to do their job. The space is needed because snow plows often are rigged with “wing” blades extending 10-12 feet to the side. The blades often have blinking warning lights at their tips, but in blowing snow conditions those warning lights may be obscured. The snow plow may be longer than anticipated, as front blades extend ahead of the cab. The snow they kick up can blind vehicles following too close. The plowing can also eject pieces of ice, which can crack windshields.

In order to expedite the prompt and efficient removal of snow from the streets, please keep vehicles parked off the road when it is snowing. Do not shovel, plow or blow snow onto roadways. This is prohibited by law and can cause a traffic hazard. It is best to place snow on the side of your driveway opposite the direction the plow approaches. This will allow the plow to carry snow away from your driveway instead of filling your driveway back in. If possible, wait until the roads have been plowed and pushed back before clearing your driveway. There is no practical way to clear the streets without depositing some snow in driveways. Snow banks must be pushed back to provide drainage for the next storm.

Plowing, sanding, salting, and snow removal takes time. During storms of long duration, crews work around the clock until everything is done. Our primary mission is to make roadways safe for the traveling public at a reasonable cost to our taxpayers.

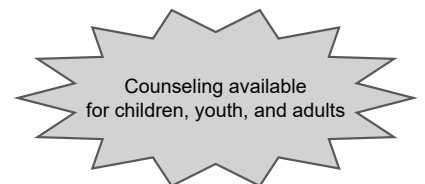

As the 2021 year comes to a close, LTMA has been going through some big changes. I would like to thank the Waterford Waterworks customers for their patience on the new Trout Ave waterline. I know it has been a big inconvenience for everybody but D & M Construction has been moving fast and ahead of schedule. Completion of the project should be no later than the first week of January. After this project is done, we have another big one coming. A lot of our customers received easement letters. The Authority is planning to put a new water tank down in Darlington, replace some water lines, connect some water lines for loops, and put in Booster stations to provide people with adequate pressure. We are currently replacing water meters, and your help would greatly be appreciated for scheduling. I know this can be an inconvenience.
