## Dumpster Day

Dumpster Day on Old Lincoln Highway West is May 1, 2004 from 9:00 a.m. to 12:00 Noon. ID will be checked by the Ligonier Township Police Department. Ligonier Township and Ligonier Borough and Laurel Mountain Borough residents only. The following fees will apply to future collection days:

- \$10.00 per truckload
- \$2.00 per regular-sized tires - tires on rims \$4.00
- \$10.00 per refrigerator or other appliance
- \$5.00 per carload
- \$5.00 per large-sized tires - tires on rims \$10.00

Tires on rims require extra labor to remove rims, our Tire Disposal Service will not accept tires on rims.

For a small number of pieces, no charge will be made, but donations are always accepted and appreciated. The following items will not be accepted:

## UNIFORM CONSTRUCTION CODE UPDATE (Act 45 of 1999)

### What does the UCC cover?

Construction	Alteration
Repair	Movement
Equipment	Removal
Demolition	Location
Maintenance	
Occupancy (classification)	
Change of Occupancy (classification)	

### What does the UCC NOT COVER?

(1) New buildings or renovations to existing buildings for which an application for a permit was made to the Department or a municipality before April 9, 2004.

(2) New buildings or renovations to existing buildings on which a contract for design or construction was signed before April 9, 2004.

(3) The following structures if the structure has a building area less than 500 square feet and is accessory to a detached one-family dwelling: (NOTE THESE STRUCTURES STILL REQUIRE A TOWNSHIP ZONING PERMIT PRIOR TO CONSTRUCTION).

- (i) Carports
- (ii) Detached private garages
- (iii) Greenhouses
- (iv) Sheds

(4) An agricultural building defined under section 103 of the Act (35 P.S. § 7210.103).

(5) Manufactured or industrialized housing shipped from the factory under Section 901(a) of the Act (35 P.S. § 7210.901(a)) as provided in § 403.25 (relating to manufactured and industrialized housing).

(6) Installation of tubing, piping, propane gas burning appliances, equipment or fixtures related to liquefied petroleum gas under the Propane and Liquefied Petroleum Gas Act (35P.S. §§ 1329.1-1329.19).

(7) Construction of individual sewage disposal systems under 25 PA Code Chapter 73 (relating to on-lot sewage treatment facilities). (Note: An on-lot septic permit issued by the Sewage Enforcement Officer will still be required by the State).
