Concerned about increases about traffic, and opposes rehab centers Julia Ritter. Wants to preserve qualities of Agricultural District and former Conservation District

Jim Zulisky. Agrees with previous speakers. Concerns about narrow condition of Austraw Nora McLanahan. Requested update on zoning code review, and concerned about development impacting well water quality

Old Business

Zoning Code updates:

Chairwoman Nalle reports the Commission is making good progress, with the help of the Zoning Officer. When the Commission feels they have a document ready to recommend to the Supervisors, they will do that at a public meeting, which will then go before the Supervisors. Supervisors will review, add, change, take things away, and then hold a public hearing. Only after that will it become the updated zoning code. The Supervisors are the final decision makers. Chris Hefner says the Commission is not making wholesale changes to how properties are zoned. The Commission is not changing A-1 to R-2 or anything like that. The Commission is plugging holes and defining new things.

Mrs. Nalle gives examples of things we are defining, such as wind farms, AirBNBs, marijuana dispensaries.

Mr. Hefner says that the Commission is trying to be proactive with the zoning code review.
